The parcel label with its bar-coded information forms the logistical basis of the DPD Romania system. For all parties involved these specifications define the standard, which is essential to the production and use of the DPD Romania parcel label. The DPD Romania system can only be operated at a high-quality level if these specifications are complied with.

The DPD Romania routing label must have the format DIN EN ISO 216 A6 (equivalent to 105x148 mm) and includes the following sections:

1. DPD Romania barcode. The barcode format is Code 128 and contains the parcel number and routing information.



2. General shipment information - In the first section (on the left) is the DPD Romania logo, the sequential number of the parcel and the total number of parcels ("1/1 of") and the waybill number (51963801171), masked COD amount and declared value for the shipment. Next is the pick-up/drop-off date and time section and on the right - the calculated delivery date.

3. Courier service information - ID number and name of the courier service, used for the shipment.

4. Sender section - contains information about the sender of the shipment: The sender's phone number is masked to be compliant with GDPR; Sender name might also require masking for GDPR; Sender contact name (the person who is sending the shipment - mandatory if the sender is a company); Sender address in two lines.
